- 1. The Government of the United Republic of Tanzania has received a grant from International Development Association (IDA) and Global Agriculture and Food Security Programme (GAFSP) towards the cost of the Expanding Rice Production Project, and it intends that part of the proceeds of these funds will be applied to cover eligible payments under the contract for Construction of Warehouse facilities at Mbogo Komtonga Village in Myomero District Council, Morogoro region.
- 2. The Myomero District Council invites sealed bids from eligible bidders for Construction of Warehouse facilities at Mbogo Komtonga Village in Myomero District Council, Morogoro region

- 3. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's <u>Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers</u> [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers January 2011 (revised on July, 2014)] ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
- 4. Qualifications requirements for the works include: (i) experience as prime contractor in construction of at least two works of similar nature and complexity in the last five years with minimum value of TZS 526,224,000 (ii) minimum annual volume of construction work for the last five years of TZS 1,096,300,000 (iii) minimum amount of liquid assets and/or credit facilities net of other contractual commitments of TZS 438,520,000. Procurement of the Works under this bid is advertised and will be executed concurrently with other four (4) similar bids for Works Packages that are under ERPP in Morogoro region namely (i) Rehabilitation of irrigation infrastructure works and rehabilitation of access road at Myumi in Kilosa District council, (ii) Rehabilitation of irrigation infrastructure works at Kigugu irrigation scheme in Myomero DC (iii) Rehabilitation of irrigation infrastructure works and rehabilitation of access road at Njage in Kilombero District council, and (iv) Construction of warehouse facilities at Msolwa Ujamaa irrigation scheme in Kilombero DC. Hence, award Criteria for Multiple Contracts, Employer will aggregate minimum requirement for respective lots/packages/bids as specified under items 3.1, 3.2, 4.2(a) and 4.2(b). However, with respect to the specific experience under item 4.2 (a) of Section III, Option (b) for multiple Contracts (option 1) shall apply. With regards to Key Personnel and Equipment, to be awarded multiple contracts, the bidder must present separate sets of equipment and separate teams for each package. Further details and complete qualification requirements are provided in the Bidding Document.
- 5. Interested eligible bidders may obtain further information from Secretary to the Tender Board, Mvomero District council. Offices are open from 09:00 hours to 15:00 hours local time from Mondays to Fridays inclusive except on public holidays.
- 6. A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee⁴⁰ of Tanzania Shillings One Hundred Thousand only (Tzs 100,000.00) or its equivalent in a freely convertible currency. The method of payment will be either by Cash, Banker's Draft, or Banker's Cheque through NMB Bank Account No. 22710000250 payable to District Executive Director, Myomero District Council, P.O Box 663, Morogoro.

- 7. Bids must be delivered to the address below on or before 20th June, 2018. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on 20th June, 2018 at 11:00am.
- 8. All bids must be accompanied by a Bid Security of Tanzanian shilling Ten Million Only (TZS 10,000,000.00) or its equivalent in freely convertible currency. The Bid Security shall be clearly addressed to the District Executive Director, Myomero District Council, P.O. Box 663 Morogoro and shall be valid for twenty-eight days beyond the bid validity period (i.e. 148 days) after the bids submission deadline.
