De Bruyne, 33, was part of the Red Devils side that finished third at the World Cup in 2018, but they have failed to make the semifinal

at a major tournament since.
"It's too early to answer,"
De Bruyne told reporters
when asked whether the defeat to France could spell the
end of his international career. "Let me process this loss. It's a been a very long season. I need to rest my body. I will make my decision after the summer."

De Bruyne, who made his Belgium debut in 2010 and has over 100 caps for his country, remains an integral part of coach Domenico Tedesco's plans shead of the World Cup in the United States, Mexico and Canada in 2026.

"He knows how impor-tant he is." Tedesco said of the Manchester City mid-fielder's comments at a news conference. "He doesn't need to point about it because he knowe humediately after he knows. Immediately after the game, it's difficult to ask these kinds of questions to
